Standard Terms and Conditions of Sale located on the company website set forth above, the Applicant's purchase order, the Clear Source IT, Inc., ("CSIT"), order confirmation or invoice, the Credit Application, and the Individual Guarantee which are the exclusive terms and conditions governing any and all sales and purchase transactions between CSIT and Applicant which shall not be modified in any way except by a writing signed by both CSIT and Applicant.

2. By submitting this application, I authorize CSIT to make inquiries into the banking and business/trade references supplied by Applicant. If Applicant pays the full purchase price before the product is shipped, Applicant need only complete Section A of the Credit Application.

3. I acknowledge that ClearSource IT is an independent supplier of IT hardware and software and does not represent any manufacturer. Additionally, I understand that ClearSource will not sell Cisco product to Cisco Partners and I have accurately and clearly stated my company's partner status in the Credit Application.

Applicant hereby makes application for credit and provides the information contained herein for the purpose of CSIT, a Colorado corporation, making periodic sales of goods on credit to the Applicant. In consideration thereof, it is agreed and understood that:

(1) I am an authorized agent of the Applicant and am duly authorized to enter into and make a binding agreement on Applicant's behalf. (2) Applicant authorizes its creditors, above credit references, banks and financial institutions to release any and all credit, banking and financial information to CSIT. (3) All payments shall be made to Clear Source IT, Inc., 14 Inverness Drive East #F-100, Englewood, CO 80112. (4) All past due accounts shall bear interest at the rate of 2% per month on the outstanding balance, or the maximum legal rate, whichever is higher. (5) Applicant agrees to pay \$25.00 for each check issued by Applicant to CSIT which is returned to CSIT for non-payment. (6) Applicant waives notice of default and demand for payment and agrees to pay all expenses of collection including reasonable attorney fees and related costs and any and all applicable interest thereon. (7) CSIT at its sole discretion may at any time amend, revised, or update the Standard Terms and Conditions of Sale, change payment terms, credit limit, or cease further extensions of credit to Applicant. (8) Delivery of all goods covered by this Agreement shall be F.O.B. CSIT's warehouse. All risk of loss, damage or destruction shall pass from CSIT to Applicant upon transfer of possession to the common carrier. CSIT shall in no event be liable for any direct, indirect, special, incidental, consequential, or other damages suffered by Applicant due to delay in shipment.
